Unisem Ipoh proposed to change the 16QSOP from the current high density leadframe (HD) to a matrix leadframe due to the high density leadframe production line is underutilized. The bill of material will remain the same and the package outline drawing is the same except the package stand-off which is changed to meet JEDEC MO137.
